#### LAC QUI PARLE COUNTY PARK ORDINANCE

#### ENVIRONMENTAL PROTECTION

- (1) The park environment is for the enjoyment of all. It is, therefore, unlawful for any person to destroy, injure, or damage any land or personal property of the County, including but not limited to trees, vegetation, ruins, relics, and geological formations, except collections for scientific or educational purposes are permitted by written consent of the Commissioner.
- (2) It is unlawful for any person to injure or molest any wildlife within a county park.

## FIRES AND REFUSE

- (1) Fires are permitted only in fireplaces or fire rings provided for that purpose.
- (2) It is unlawful for any person to burn or otherwise despose of garbage, refuse, sewage, or trash of any kind except to dispose of the same in receptacles provided for that purpose.

## MOTOR VEHICLE TRAVEL

- It is unlawful to operate any motor vehicle within the boundaries of any County park except upon designated roads or parking areas.
- (2) It is unlawful for any person to operate any vehicle at a speed in excess of the posted speed or in a reckless or careless manner.
- (3) It is unlawful to operate any motor vehicle on roads which are posted, chained, or gated prohibiting vehicular traffic.
- (4) It is unlawful to park any motor vehicle in other than designated parking areas.
  - (5) It is unlawful for any person to operate an unlicensed motor vehicle.

# DEFINITIONS

For the purpose of these rules, unless a different meaning is manifest from the context, the terms defined in this section have the meanings given them.

- (1) "Drug" means any drug, the possession of which is in violation of federal or state law.
- (2) "Motor Vehicle" means any self=propelled vehicle. The term shall include but not be limited to automobiles, trucks, snowmobiles, dunebuggies, minibikes, motorcycles, trail bikes, and all terrain vechiles (ATV).
- "Person" means any individual, partnership, corporation, or association.
- (4) "Snowmobile" means any engine driven wehicle of a type which utilizes sled-type runners, or skis, or an endless belt tread or any combination of these or other similar means of contact with the surface upon which it is operated and which is designed to operate over ice or
- (5) "County Park" means any legislatively designated county park, county monument, county recreation area, and state wayside. Ene amost 1 - 15-81

# PARK-HOURS

County Parks will be open each day of the year from 8:00 A.M. to 10:00 P.M., provided, however, when designated snowmobile trails are open for use, snowmobiles may be operated on said trails from daylight to 11:00 P.M.

It shall be unlawful for any person to participate or engage in any activity which disturbs the outdoor solitude of other campers after 10:00 P.M.

## PERSONAL BEHAVIOR

It is unlawful for any person to engage in any violent, immoral, abusive, loud, obscene, or other conduct creating or tending to create a breach of the peace or to disturb or annoy the recreational enjoyment of park lands and waters by other members of the public.

## DRUGS

It is unlawful for any person to use, be in possession of, or be under the influence of drugs.

## PUBLIC SAFETY

- (1) It is unlawful for any person to display or have in his possession a firearm or air gun unless unloaded in both barrels and magazine and cased.
- (2) It is unlawful for any person to have in his possession explosives of any kind.
- (3) It is unlawful for any person to use or display any other type of weapon, including but not limited to, slingshots or switch blades.

#### CAMPING AREA

Campgrounds in County Parks are established for the convenience and pleasure of the tourist and vacationer for overnight camping use. They are not intended as a place for permanent or semi-permanent residence, a base for the operation of a business, or a facility for noncamper use. Campground roads and facilities are for use of the campers and guests of same and shall not be used for just "driving through."

(1) Permits for overnight camping must be obtained at the Sheriff's Office or local police department designated by the Sheriff at Madison, Minnesota, prior to overnight camping, and said permit must be in possession at the time.

## PENALTY

Any person who shall willfully violate any rules promulgated herein shall be subject to immediate removal from the park or guilty of a misdemeanor or both.
