Actual Results	<p>LGU staff reviewed approximately 220 drainage permit applications for wetland impacts and informed applicants of options if potential impacts involved. Staff reviewed and approved credit release requests for both wetland bank sites following site visit confirmations. Seven exemptions applications were submitted, reviewed, and approved. Two approved exemptions were under Subpart 2 (Agricultural Activities), 1 under Subpart 3 (drainage), and 4 under Subpart 2g (Agricultural wetland bank exemption). Staff informed and assisted 7 landowners with requests to perform maintenance in DNR protected public waters. Staff assisted 3 landowners with questions about potential bank sites. Staff assisted numerous landowners with various inquiries: \$3,219.72.</p> <p>The LGU board reviewed and approved 211 drainage permits and 3 exemption applications: \$580.00</p> <p>Dakota Wetlands Law &amp; Compliance Registration: \$289.00</p> <p>Legal Advice: \$227.50</p> <p>BWSR Regional training registration: \$40.00</p> <p>Postage: \$172.58</p> <p>Envelopes: \$105.00</p> <p>Copier Expense: \$633.00</p>

Staff spent a large amount of time working with Technical Evaluation Panel and DNR regional enforcement officer on the preparation, issuance, and follow up of a violation restoration order. Two additional violations remain under investigation. Staff assisted landowners with numerous site visits. Staff attended and assisted with a Conditional Use Permit hearing. Staff reviewed with TEP and assisted with application and proceedings of an Agricultural Wetland Bank Application and the initial credit release. Staff participated in Dakota Wetlands Law and Compliance Webinar training and BWSR regional training: Trudy - \$789.28; Mitch - \$10,461.75</p>
