## **LAC QUI PARLE COUNTY PARK RULES AND REGULATIONS**

**ADOPTED BY COUNTY BOARD: 11/1/2022**

### **PARK HOURS**

Unless otherwise noted, or to prevent damage to the roads/trails, the Park will be open each day of the year. Quiet time in the Park will be from 10:00 p.m. to 7:00 a.m.

### **CAMPING IN THE PARK**

Short term *recreational* camping is allowed in the Park on a first come first serve basis. No campers or tents will be allowed to stay in the park for more than nine (9) days. A violation will result in the removal of the individual and camper/tent at the owner's expense.

### **PAYMENT BOXES**

A \$20.00 donation is requested for each night you stay in the Park. Payment boxes are located at each entrance and by the bathroom.

### **ENVIRONMENTAL PROTECTION**

The Park is for the enjoyment of all. It is therefore unlawful for any person to destroy, injure, damage or remove any land or personal property of the Park, included but not limited to trees, chopping or sawing, vegetation, ruins, relics, and geological formation, except collections for scientific or educational purposes are permitted by written consent of the Park Board. It is unlawful for any person to injure or molest wildlife within the Park.

### **RECREATIONAL FIRES AND REFUSE**

Recreational fires are permitted only in fireplaces or fire rings provided for that purpose. It is unlawful for any person to burn or otherwise dispose of garbage.

### **OPERATION OF MOTOR VEHICLES IN THE PARK**

Motorized vehicles, as defined by Minnesota Statutes to include automobiles, snowmobiles, dune buggies, ATV, dirt bikes, **must** yield to all others including horseback riders, people and bikes. It is unlawful to operate or park any motor vehicle within the boundaries of the Park except upon designated roads or parking areas, excess of 10 mph, or without valid license or current registration in the Park.

### **DRUGS/ALCOHOL**

It is unlawful for any person to use or be in possession of any illegal drug and the consumption of alcohol must be done in a responsible manner.

### **PERSONAL BEHAVIOR**

No person shall engage in behavior or activities that limit the use and enjoyment of the Park by others.

### **PUBLIC SAFETY- NO HUNTING**

No firearms, pellet guns or air guns shall be possessed or used inside or into the Park. No explosives shall be used inside the Park. No bow and arrows or cross bows shall be used in the Park.
