### **NOTICE OF FILING**

Notice is hereby given pursuant to Minnesota Statute 204B.33, that a general election will be held in Lac qui Parle County on Tuesday, November 5th, 2024, for the purpose of electing candidates for the offices listed below. The filing period for these offices begins at 8:30 a.m. on Tuesday, May 21st, 2024 and closing at 5:00 p.m., Tuesday, June 4th, 2024. Please note that filing offices will be closed on Monday, May 27th, 2024, in observance of Memorial Day.

Candidates for County Office must be 21 years of age upon assuming office, a resident of Lac qui Parle County for at least 30 days before the general election, and eligible to vote in Minnesota.

**County Commissioner 1<sup>st</sup> District (4-year Term)** - Must be a resident of the 1<sup>st</sup> District, which includes Augusta Township, Freeland Township, Garfield Township, Hamlin Township, Madison Township, Manfred Township, Maxwell Township, Mehurin Township, Providence Township and the City of Marietta.

**County Commissioner 3<sup>rd</sup> District (4-year Term)** - Must be a resident of the 3<sup>rd</sup> District, which includes the City of Madison.

**County Commissioner 5<sup>th</sup> District (4-year Term)** - Must be a resident of the 5<sup>th</sup> District, which includes Baxter Township, Camp Release Township, Lac qui Parle Township, Riverside Township, Ten Mile Lake Township and the City of Boyd.
